PLEASE READ CAREFULLY AND RETAIN FOR FUTURE REFERENCE

Trade Customers, prices and conditions of sale

Products in the JP range are intended for resale and are available at trade prices only to bona-fide businesses. Proof of trading will therefore be required in addition to trade references (details in our account application form).

At our discretion a JP sales representative may call you in order to discuss your particular trade requirements and to arrange a visit to your premises at your convenience in order to ascertain trade status.

Please note that we reserve the right to refuse trade facilities to any customer or potential customer at our discretion. We reserve the right to change trade prices and Suggested Retail Prices (SRP's) at any time at our discretion. SRP's may be listed on our website, printed on Invoices, price lists, etc and are intended to be helpful guide prices only and are in no way binding.

Goods are offered for sale subject to availability and are sold subject to our Trading Terms and Conditions.

Trade Prices

Trade prices shown in our price list are exclusive of VAT, and are correct at the time of printing. Prices are subject to change at any time.

Conditions of Trading

Initially, orders will be accepted on a Nett, Pro-Forma basis only. Later, credit facilities & settlement discount may be made available (if requested) entirely at our discretion and subject to satisfactory references and whatever trade enquiries we feel it appropriate to make.

Should we require credit references for any customer, we reserve the right to request credit-related information from third parties and from on-line credit reference databases.

Should trade facilities be approved, any credit limit allowed will be subject to periodic review. We reserve the right to withdraw credit facilities without notice should you fail to observe our trading or credit terms.

Accounts that we deem inactive will be subject to closure and withdrawal of all trade facilities, trade pricing and discounts without notice.

Goods remain the property of J. Perkins Distribution Ltd, until such time that payment has been received in full. Title is retained over all goods previously supplied to the value of outstanding invoices.

Access to the JP TradeDesk is account status dependant and we reserve the right to refuse or revoke access at our discretion.

Statements

A statement of your account will be sent to you monthly. Please check that all transactions agree, if they do not, please contact the Accounts Department immediately.

Minimum opening order value

To be not less than £500 goods value at trade prices (excluding VAT).

Payments & Discounts

Where credit facilities & settlement discounts are granted, all invoices become due for payment at the end of the month following date of invoice.

For invoices paid by BACS or cheque within 30 days of invoice date, 2.5% settlement discount may be deducted from the goods value only.

For invoices paid by BACS or cheque within 7 days of invoice date, 5% settlement discount may be deducted from the goods value only.

Card payments - Please note that terms are NETT 30 days for Invoices settled by card.

When paying by card within 7 days of Invoice date, 2.5% settlement discount may be deducted from the goods value only.

When paying by card for Invoices amounting to a goods value of below £40 no discount will be allowed.

Overdue balances - No goods will be supplied until such times as all outstanding overdue balances have been paid in full.

Shortages & damaged goods

Deliveries - All discrepancies or damaged deliveries must be marked as such on any relevant carrier documentation and reported to our Sales

Department on the day of delivery into your premises.

Please check deliveries carefully for damage and for missing cartons.

Unfortunately, we are unable to process claims for goods signed as received in good order which upon later investigation in the shop are found to have damaged exterior cartons. Similarly, we are unable to process claims for missing cartons that have been signed in by you or your staff as delivered into your premises.

Faulty and returned Goods.

No goods, faulty or otherwise can be accepted by J Perkins Distribution without prior consent and arrangement.

Faulty goods should be returned via your JP representative and a detailed receipt obtained at the time of return. If you do not have a sales representative, please call our sales office with details of the Invoice number relating to the goods in question and the nature of the fault. Our service/sales staff will be pleased to advise you if - and to where or to whom - a return should be made.

Goods returned as faulty but which are found upon examination by our technical service staff to be free of any fault will, at our discretion, incur a handling and examination charge.

Restocking charge - We reserve the right to apply, at our discretion, a restocking charge on any items returned for credit which have been correctly supplied in good faith and in good condition by J Perkins Distribution Ltd.

Back orders

We do not hold back orders for items we have 'no-stocked' on your Invoice, unless you specifically request this in writing.

Normally, we will send these items with your next order. If you require them to be sent earlier; normal JP carriage charges will apply if the order value of back order items is below 'carriage paid'.

If you do require that we hold back orders for you, please ask our accounts dept. for a copy of our back orders form.

Small orders

Orders under £40 goods value excluding VAT will attract both a postage charge AND a minimum £1.50 packing charge.

Orders for fuel only

Orders received for model fuel only will be subject to a heavy item surcharge in an additional to any carriage chargeable.

Carriage Charges

UK Mainland Goods value over £200 nett will be sent carriage free.

Scottish Highlands... Invoices over £300 nett will be sent carriage free.

Southern Ireland Invoices over £300 nett will be sent carriage free.

Channel Islands..... Invoices over £300 nett will be sent carriage free.

Northern Ireland..... Invoices over £300 nett will be sent carriage free.

Orders under these values will incur a carriage charge, please contact us for information.
